2013 OSMT Annual Report

n 2013, the Board and members celebrated the 50th Anniversary of the OSMT. It was a year that marked five decades of leadership, service, and advocacy for the medical laboratory professionals of Ontario. It was a time to reflect and be proud of the difference our work has made, and continues to make, to the enrichment of the professional lives of our membership.

OSMT 50th Anniversary Events

The year presented many opportunities to spotlight the thousands of laboratory professionals who play a vital role in healthcare delivery. The first round of the celebrations was held in the spring to capture the momentum and zeal that's always generated by National Medical Laboratory Week. District Directors and other Board members organized special events across the province that ranged from informative, and sometimes amusing, education sessions, wine and cheese get-togethers, and healthful mind and body exercises.

District 8 hosted "Kicking off our Golden Anniversary Celebrations" at St. Joseph's Health Centre in London. The event featured an entertaining presentation by the CSMLS about "Generations 2.0 Listen and Be Heard", their values and beliefs, and how to optimize their contributions in the workforce. ORBCoN representatives spoke about "Contingency Planning" and "Ontario's Redistribution Plan for Blood Products and Shortages" and ways in which hospitals are required to deal with them.

In Kingston, an interactive presentation on "Ethical Decisions: Ethical Practice" was held at St. Lawrence College. Later in the evening, everyone kicked back with a glass of wine and indulged both in edible food and the food for thought that was stimulated by the earlier 'ethics' conversations.

District 1 organized the "Flourish and Focus" event in Thunder Bay. The day's activities centered on ways to balance our hectic lives and to flourish in our "do more with less" work environment. A Tai Chi lesson in the morning was followed by an insightful, energetic, and humorous glimpse into the latest research about happiness. A chef's lunch demonstrated the benefits of eating healthy and local. Scientific sessions were presented on "Common Cancers" and "Cancer Treatment in an Era of Personalized Medicine". The day concluded with meditative Yoga that left everyone feeling rested and refreshed.

In District 5, the Toronto College Park campus of Everest College held an information session for about 100 medical laboratory assistant/technician students from across the GTA. The luncheon, door prizes, and networking opportunities made for an enjoyable and informative day for all.

Advocacy and Communications

Since the founding of the Society in 1963, the OSMT has advocated to improve the professional lives of medical laboratory technologists and technicians in Ontario.

It is the role of the OSMT to keep abreast of emerging issues and how they might impact laboratory professionals. We engage in discussions with government, educators, regulators and other organizations about identified priorities. We represent the membership on many fronts including representation on numerous groups and committees.

Other communication and promotional activities included:

- Presentations of the *Politics of Professionalism*, which introduces the key stakeholders and features recent developments and current issues that impact the medical laboratory profession.
- ◆ Meeting with the CMLTO about the College's *Enhanced Professionalism* project and exploring ways to support this initiative.
- ◆ Sponsorship of the Kenora-Rainy River Regional Laboratory Program annual symposium.
- ◆ Discussions with LifeLabs Medical Laboratory Services and the Ontario Coalition for Lab Reform about the acquisition of Canadian Medical Laboratories (CML) by LifeLabs in the fall of 2013. The OSMT provided each group with a venue to present their perspectives on the OSMT's website.
- Sponsorship and attendance at numerous career fairs.
- Obtaining information about some proposed approaches that are being considered in the development of new regulations, programs, and policies under the *Human Pathogens* and *Toxins Act*.
- ◆ Participating in a Ministry of Health and Long-Term Care *Technical Briefing on Bill 117 Enhancing Patient Care and Pharmacy Safety Act*. This Bill is the government's response to the chemotherapy under-dosing issues that occurred this past spring to cancer patients at several Ontario hospitals.

OSMT Conference

The OSMT's 2013 Conference was held in London, Ontario, exactly 50 years from the date of the OSMT's first Annual General Meeting in the same city. The theme of the conference was "50 years of history ... with eyes to the future". In keeping with this theme, a conference logo

Membership

During our 50th anniversary year, the OSMT took time to remember its rich history of accomplishments, landmarks, and challenges. Four issues of the *Advocate* publication included highlights from our past and the cover of the Spring 2013 issue bore our anniversary logo and was printed with gold foil lettering. In appreciation of the loyal support of our membership, an OSMT 50th anniversary commemorative flash drive with two recorded education sessions was sent to all our 2013 members. Our anniversary membership brochure featured important milestones from each decade of the OSMT's history to be added to the chronicles of the Society.

The OSMT's 2013 membership totaled 2,353, with a composition of 41% MLTs, 53% MLA/Ts, and 6% Students and other categories. This was the second consecutive year in the history of the OSMT that the number of MLA/T members surpassed MLT members. Overall, there was a reduction of 4% in memberships since 2012, predominantly in the MLT category. The Board recognizes that the decline in membership in recent years needs to be addressed. During 2013 the Board began to roll out its strategic priorities to deal with the decline in membership. Plans are currently being made for the OSMT District Directors to visit some of their area laboratories in the coming year to poll laboratory technologists and technicians about what services and benefits they would value as OSMT members.

The OSMT has been providing its members with Professional Liability Insurance (PLI)

protection since the early 90s. In 2013, the College of Medical Laboratory Technologists of Ontario (CMLTO) passed a bylaw that will require all practicing members of the College to have PLI by March 31, 2014. The College stated that most Ontario hospital and community laboratory employers carry insurance for their practicing MLTs that meets the criteria described by the bylaw. While the OSMT endorses this PLI requirement, the Society is concerned that most employer policies will not cover certain situations such as legal representation for disciplinary hearings with regulatory bodies such as the CMLTO. The OSMT Board felt this was critical information to convey to our members and utilized numerous means to get this message to the membership.

Medical Laboratory Assistant/Technician (MLA/T) Certification program

Our MLA/T Certification program, and the people who became members after achieving certification, have contributed greatly to the success and longevity of the OSMT. It was in 1988 that the OSMT offered its first MLA/T Certification exam and during the next decade, MLA/Ts gained a significant role in the society. Since its inception, 12,495 individuals have achieved MLA/T certification. The OSMT has made substantial investments and has a strong commitment to this program and has a continuous validation process to ensure that the MLA/T exam is up-to-date and consistent with Ontario legislation and workplace practices.

Collaborative Education Fund (CEF)

In 2013, the Society established the new OSMT Collaborative Education Fund (CEF) to provide support and sponsorship for professional development initiatives that positively impact and enhance the skills and knowledge of medical laboratory professionals. Education events such as seminars, conferences, and workshops, which are held by health institutions or health-related organizations and groups, are eligible for sponsorship. Events may be organized by non-laboratory healthcare professions and must contain programming and content that will be of benefit to medical laboratory professionals. Support from the CEF is available to organizations and groups by application to the OSMT Professional Development Committee.

Financial Statements

As has been the case for numerous years now, the Society continues to enjoy a solid financial condition. The year 2013 closed with a healthy \$1,762,794 in net assets, \$700,000 of which has been earmarked in a Program Development Fund. Some of this will be used for technology acquistions and upgrades and the development of new or improved initiatives during implementation of the OSMT's strategic priorities.

The 2013 Financial Statements show total revenues of \$650,061 and expenses of \$555,425. It is noted that the Society's top revenue source is from the Laboratory Assistant/Technician certification program, followed by income from membership fees. The year ended with \$94,636 in net income.

No extraordinary commitments or contracts were outstanding at the end of the year. The Society maintains a \$250,000 internally-restricted reserve as protection against operating costs.

The new Canadian Audit Standard requirements demand a more vigorous audit of certain areas of operations and reporting structures have been modified to comply with current best practices in recognizing assets and liabilities.
